Membership Fees and Further Information



Dear athletes & parents/guardians,

In order to be able to guarantee the quality of our training from a financial point of view, we collect a sport-related department contribution from our active participants. If you no longer want to participate in the training or if you want to switch between departments and the payment is to be suspended/changed, notify the respective department manager in writing (by email) no later than four weeks before the end of the quarter. The department contributions are staggered as follows:

Aikido

per department member 14.00 € per month

Basketball

per department member 2.50 € per month

Archery

Kids & teens (up to and including the age of 17) 30.00 € per month

Adults (ages 18 and above) 60.00 € per month

Families 125.00 € per year

The archery department charges a one-time admission fee for teens up to the age of 18 10.00 €
adults 20.00 €

On the first three evenings, the following equipment will be free of charge as a part of the trial phase: bows, arrows, quivers, gloves, and arm guards. After the trial phase, a rental fee of 20.00€ per month will be charged.

The admission fee and the department contribution, pro rata, for the current year are to be transferred to the department account, only then does the membership begin. Starting the following year, the department fee will be collected by SEPA direct debit as an annual fee on April 1st.

Handball

Single contribution 2.50 € per month

Family contribution 4.00 € per month

Gymnastics male & female

adults (ages 18 and above) 8.00 € per month

Kids & teens (up to and including the age of 17) 6.00 € per month

Members of the booster club receive a discount on the departmental contribution upon application to the department head including the submission of proof of membership in „Association for apparatus gymnastics in Ramstein e.V.“.

Cheerleading

Kids & teens (up to and including the age of 17) 10.00 € per month

Students 10.00 € per month

Adults (ages 18 and above) 13.00 € per month

The Cheerleading department charges a one-time admission fee for teens and adults of 50.00 €

Extract from the statutes of TV 03 Ramstein e.V.

5. Memberships

5.1 The association has regular members, young members, and honorary members.

5.2 Regular members are all members who have reached the age of 18.

5.3 Young members are all members who have not yet reached the age of 18 (sic).

5.4 Honorary members are appointed by the general assembly (section 11.1.7.4).

6. Admittance

6.1 Membership can be acquired by all blameless persons.

6.2 Admission must be applied for using the forms issued by the association (declaration of admission) and is carried out by the main board (Section 12.4.2). Applications for membership can only be rejected for important reasons.

6.3 When accepting applications from minors, the application must be signed by the legal representative.

7. Termination

7.1 Membership ends with the death of the member, through voluntary resignation, or involuntary removal.

7.2 Resignation is only permitted at the end of a calendar quarter and must be communicated to the main board in writing at least 3 months in advance.

7.3 Membership may be revoked if:

7.3.1 the member grossly violates the interests of the association or the contents of the associations statutes, whereby unfair, unsporting behavior towards other association members is also considered a reason for removal.

7.3.2 The member owes payment of membership fees for more than 6 months, despite having been sent two reminders.

7.4 The removal of a member takes place by resolution of the main board. An appeal against this resolution, which must be communicated in writing, is given in accordance with Section 6.3.

7.5 Upon termination of membership, all claims to the association expire. Association property is to be returned immediately.

8. Rights and duties of members

8.1 Each member is entitled to promote his sporting interests within the association's possibilities.

8.2 Membership rights are not transferable.

8.3 Every member is obligated to follow these statutes, to comply with the orders of the association's members, and to pay the fixed membership fee (obligation to provide).

9. Membership fee

9.1 The membership fees are set by the (sic) main board.

9.2 The honorary members are exempt from the obligation to contribute.

Extract from the rules of procedure of TV 03 Ramstein e.V.

2. Membership fees

2.1. The monthly membership fees are set as follows (from 01.01.2017):

2.2. Regular contribution

Everyone over the age of 18 pays the normal contribution, unless an exception according to 2.3., 2.4. or 2.5. is applicable.

2.3. Family contribution

In the family contribution, parents can be combined with their children at a reduced rate. At least one adult and one child (or grandchildren) or a married couple or several siblings are required. Children up to the age of 18 or without their own income (proof required) can be included in the family contribution upon application, up to the age of 27.

2.4. Reduced contribution applies for:

2.4.1. Children and teenagers up to the age of 18

2.4.2. Students, Bundeswehr, FSJ students, and social welfare recipients receive the reduced fee for a limited period upon application by resolution of the general meeting. This time limit applies to the duration of studies, compulsory military service, the social year or the need for social assistance. Evidence of the reason for the reduction must be provided to the AGM annually.

2.4.3. Pensioners can apply for an unlimited reduced contribution by resolution of the general meeting.

2.5. Upon application, members can be granted a special contribution in exceptional cases by resolution of the general meeting.

2.6. Each member is free to pay a higher fee than specified above.

2.7. The under 2.4.2. (temporary) and 2.4.3. listed contributors are to be recorded in a list and announced annually to the AGM.
